# SECOND PUBLIC HEARING MINUTES Town of Havana FFY 2017 CDBG Application August 7, 2018

Mayor Ross opened the public hearing at 3:00 pm. He then handed the meeting over to Mrs. Robin Phillips with Jones-Phillips and Associates, Inc. Mrs. Phillips said that this was the second public hearing for the CDBG application process. She said that the Town was applying for a CDBG Neighborhood Revitalization project for the renovation and upgrade of the wastewater treatment facility (WWTF) and that the amount of the grant was \$650,000. Mrs. Phillips then went over the budget for the grant. She said that the renovation of the plant would be \$598,000 of the budget and \$52,000 would be for administration. She said that the application will be going in to DEO on August 13, 2018 and if it ranks high enough for a site visit that will take place in September. She said that the grant will be leveraged with a DEP Revolving Loan for the remainder of the cost of the plant, approximately \$5 million. The Town agreed to match the project will \$50,000 from the general fund. She asked if there were any questions or comments. There were none. The Council passed a resolution for the application submittal and match. The meeting was adjourned at 3:15 pm.
