HAVANA TOWN COUNCIL REGULAR COUNCIL MEETING December 15, 2020 6 pm

The meeting was called to order by Mayor Pro Tem Bert.

Invocation was led by Mr. Jerome Harris followed by the Pledge of Allegiance.

Motion to approve the minutes from the November 17, 2020 Regular Council Meeting was made by Councilman Bass and seconded by Councilwoman Hart. Motion carried.

VISITORS:

Mrs. Karen Kent, 102 E 5th Avenue, Havana, Florida, expressed her concerns regarding the new drain installed near her property. The filter around the drain is filled with concrete and trash. She stated the debris is a concern when mowing. Mrs. Kent also mentioned yard trash not being picked up by Waste Pro. Mr. Bradford Johnson, Town Manager, stated he will address the drainage issue with Florida Department of Transportation (FDOT). DOT is replacing storm drains and will resurface US 27. Also, a Waste Pro representative will attend the January's council meeting to discuss garbage collection.

Mr. Robert Willis, 118 3rd Street SW, Havana, Florida, stated his concerns regarding trash problems at his location.

Mrs. Terri Paul, President of Havana Main Street, voiced concerns regarding the bike trail resolution the council passed in December 2019. Havana is lagging behind and need to complete the feasibility study. Fifty (50) trails are now being used and this is the time for Havana to capitalize. Havana needs to complete the feasibility study in order to get back in the queue for funding. Mr. Johnson stated there was a meeting with the Havana Main Street director to discuss the current status of the resolution.

Mr. Tony Lombardo, business owner, mentioned the shock in seeing the islands removed at the intersection of 7th Avenue and US 27. The islands cost was a \$27,000 investment by the Downtown Improvements Committee. They were installed to improve the appearance of downtown. He stated there was no public discussion and no plans for removal.

Mr. Johnson stated the islands became an item when DOT began the resurfacing on US 27. DOT had a concern with trucks turning and also the ADA compliance.

Mrs. Terri Paul, Havana Main Street, inquired about the proposed ordinances submitted by Havana Main Street for design and standards being reviewed by the town's legal team. There is a need for standards and guidelines. Mr. Johnson stated there was a meeting with Main Street and the council will need to decide on hosting a workshop to further discuss passing the ordinance. After a brief discussion, the council agreed to host a workshop on January 26, 2021 at 5 p.m.

Mr. Jerome Harris, Showtime Auto Detail, Havana, Florida, and the Southside Residents Committee recognized Chief Tracy Smith and the Havana Police Department. A plaque was presented to Chief Smith recognizing their outstanding community policing. Mayor Decorkus Allen read and presented a Proclamation to Chief Smith and his department for their outstanding service.

Neighborhood Medical Center reached out to host a food giveaway event. They are requesting to use the Havana Medical Center parking lot for distribution. The Less Fortunate Foundation also have plans to host a Food/Toy Giveaway, December 24, 2020, at the Cecil G. Trippe Municipal Building. Motion to approve the events was made by Councilwoman Jordan and seconded by Councilman Bass. Motion carried.

Mr. Johnson stated the Demand Star Service Agreement will allow the town to increase capacity when going out for competitive bids. There is no cost and this will allow the town to increase exposure. Motion to approve the Demand Star Service Agreement was made by Councilwoman Jordan and seconded by Councilman Bass. Motion carried.

REPORT OF THE TOWN MANAGER:

Mr. Johnson wished all a "Merry Christmas".
