The meeting was called to order by Mayor Hart.

Invocation was led by Councilman Vickers followed by the Pledge of Allegiance.

Motion to approve the minutes from the June 24, 2021 Special Meeting for the State Revolving Fund to approve Resolution No. 2021-04R was made by Mayor Pro Tem Bert and seconded by Councilman Bass. Motion carried.

Motion to approve the minutes from the June 29, 2021 Regular Council Meeting was made by Mayor Pro Tem Bert and seconded by Councilman Bass. Motion carried.

VISITORS:

Mr. Jerome Harris, 131 East 11th Avenue, advised that he has a new organization called Havana SPAIN (Special Project Against Illiteracy and Neglect). Mr. Harris gave an overview and mentioned he will be working with the Gadsden County Judicial System, the Havana Police Department and Sheriff's office to assist people in need of transitioning back into society. Havana Spain is before the council seeking assistance with funding. Mayor Hart thanked Mr. Harris for his presentation.

Ms. Thelma Hickman, Principal for Havana Magnet School and Ms. Deborah Schaffer, Assistant Principal, introduced themselves and stated they look forward to partnering with the Town.

Mrs. Terri Paul, Wanderings, stated her concerns regarding the dumpster service for the downtown merchants. Her request is for the Town to continue collecting dumpster payments and have all dumpster moved to the parking lots.

Ms. Stacy Henderson, 331 4th Street SE, appeared before the council to voice her concerns regarding the utility billing process and procedures. She also questioned the town's extension policies. After a lengthy discussion, Motion was made by Mayor Pro Tem Bert and seconded by Councilman Bass to approve a one-month extension for the month of August. Motion carried.

Mrs. Karen Kent, Downtown Improvement Committee member, stated she is requesting to gift three lighted sculptures to add to the Christmas décor. Wayfinding signs were also discussed. During the discussion, an example of the wayfinding signs was presented to the council by Mrs. Edna Hall Whitehead. Councilwoman Stone mentioned the signage seemed too large for the areas and inquired if they can be reduced in size. The committee members will contact the vendor.

Mrs. Kent stated she is also seeking approval to increase the annual payment to the Christmas Tree Farms for the upkeep and maintenance of the lighted sculptures. The amount will increase to \$1,000 which will come from the Downtown Improvement committee funds. Motion to approve the increase to the Christmas Tree Farms was made by Mayor Pro Tem Bert and seconded by Councilman Bass. Motion carried.

Mr. Wayne Durrett, James Moore and Company, thanked the council for the opportunity to present the 2018-2019 financial audit. Mr. Durrett also thanked the town manager and all involved in the process. After his presentation, Mr. Durrett inquired if there were any questions or comments. With there being no comments, motion to approve the 2018-2019 Financial Audit was made by Mayor Pro Tem Bert and seconded by Councilman Bass. Motion carried.

Mr. Johnson mentioned the fire hydrant painting project and advised Havana Main Street and the Town are working to beautify the town. The fire hydrant painting designs were reviewed by the Town Manager, Chief of Police and Fire Chief. Motion to approve the fire hydrant designs was made by Mayor Pro Tem Bert and seconded by Councilwoman Stone. Motion carried.

Chief Tracy Smith stated Havana Main Street presented several Special Event Permits for approval. They are requesting to host Wood Fest, Pumpkin Festival, A Quilt Show and Winterfest. Chief Smith advised he recommends approval. Chief also mentioned an additional permit that was submitted from Blessings of Hope Empowerment Outreach. Blessings of Hope is requesting to host a barbeque giveaway on this Saturday at 11am. Motion to approve the special event requests was made by Councilman Bass and seconded by Mayor Pro Tem Bert. Motion carried.

Chief Smith gave a brief update on the concerns for the appearance of the old elementary school. Contact was made with the owners to clean up the property. Chief stated he is also in contact with the owner of the car lot on US 27. He explained the difficulty of contacting owners that are out of town. Mayor Hart mentioned a

constituent contacted her in regards to an old mobile home on Salters Street. Chief Smith advised that he will follow up.

REPORT OF THE TOWN MANAGER:

Mr. Johnson mentioned the Waste Pro changes. Starting September 1, 2021, all commercial customers with dumpster service will contract directly with Waste Pro. All downtown businesses were notified of this change.

There are opportunities in the county to receive funding for broadband and infrastructure needs. Gadsden County Government is planning and discussing the potential use of federal funds for both infrastructure and broadband projects. Mayor Hart and Town Manager Johnson attended a meeting and will continue to update the council on the County's role in increasing broadband throughout Havana and all of Gadsden County. Mr. Johnson also reported that the Wastewater Facility Plan and Lift Station projects were submitted to the county's contactor that is assisting them with federal projects and funding.

The Town applied for a Florida Department of Economic Opportunity (DEO) Technical Assistance Grant to fund a feasibility study for a bike trail in Havana but did not receive an award. Mr. Johnson advised that Capital Regional Transportation Planning Agency (CRTPA) has maintained focus on this project as a priority and will be working to conduct the feasibility study.

Mr. Johnson mentioned he attended the Florida Municipal Electric Association (FMEA) annual conference. The conference was held on July 20th - 22nd and advised during the board meeting legislative matters were discussed. Currently, members of the Florida Legislature are contemplating proposing policies that would limit what local governments could transfer from the electric utility fund to fund general government operations. This is an issue that FMEA's legislative team are working to mitigate. Mr. Johnson advised that he will monitor this matter and report any changes.

Congratulations to Mr. Howard McKinnon for being the second longest serving board member for Florida Municipal Power Agency (FMPA). During the FMPA board meeting that ran concurrent with the FMEA conference, Mr. McKinnon was recognized for serving fifteen (15) years as a board member for FMPA.

On July 13, 2021 the Florida Department of Emergency Management (FDEM) conducted a Regional Floodplain Management meeting. This training was mandatory for all local governments. The training was held to inform communities of the current assessment to update Flood Insurance Rate Maps (FIRM) in our area. The training is to ensure compliance with local governments that opt into the National Flood Insurance Program. Mr. Johnson stated Havana is in compliance and he is working with FDEM on

updating our flood ordinance to ensure consistency with new state and federal flood provisions.

There are several areas on 12th Avenue East that the crew has been working on for some time now due to the erosion and washout on the street. Mr. Johnson advised the areas are barricaded for safety. The Town's engineers are working with the town crew to find the problem. Also, an application was submitted to repave 3rd Street SE in 2020, but not funded. Mr. Johnson stated the application was resubmitted for funding in 2021, and the Town is now waiting to see if it will be awarded.

Mr. Johnson reported on the American Rescue Plan Act of 2021 (ARPA). There is no official word on the actual date as to when to expect the federal COVID relief funds that will be allocated to Havana. Mr. Johnson advised he will provide updates as they occur.

The July edition of the Apprise newsletter went out with this month's utility bills.

The annual Florida League of Cities (FLC) conference will be held in Orlando, Florida, August 12th - 14th. All council members that are interested in attending and have not registered must contact the Town Clerk or Town Manager.

Mr. Johnson gave a brief update on the plans for the construction of the new Havana Police Department. Plans are still under review and being drawn by the architect and engineer. All updates will be reported accordingly.

COUNCIL COMMENTS:

Mayor Pro Tem Bert stated that Blessing of Hope Empowerment Outreach placed a thank you article in the newspaper.

Motion to pay bills was made by Mayor Pro Tem Bert and seconded by Councilman Bass. Motion carried.

Motion to adjourn.






Why WAYFINDING SIGNS?

- Directional signage (Wayfinding signs) have become an increasingly important element of creating positive visitor and customer experiences. People want to know exactly where they're going with no confusion.
- Havana's business landscape is a perfect example of why Wayfinding signs are valuable because we have a very short distance to capture the attention of people as they drive through Havana, and
- Many of Havana's treasures are lost behind the solid row of brick on Hwy. 27.
- Unfortunately, Havana does not have pedestrian friendly "store fronts" on the main highway to advertise and invite people in.
- Most visitors and MANY locals do not realize Havana's shopping and dining opportunities.
- We need to let people know what's ahead <u>before they get to the turnoffs</u>.
- Wayfinding signs "speak" to visitors <u>and locals</u>, making people feel <u>invited to explore</u>; they
 make people feel like they are welcomed and feel like they belong.
- Wayfinding signs have many benefits, including boosting local businesses, promoting the
 use of local amenities and providing the nearest location for facilities, such as parking.


Havana Main Street Branding Suggestions

The results of the branding project provided us with sign designs and those are what we are proposing. The estimates received are based on these designs. At this time we are proposing three different sign types/sizes:

- Sign Type A These signs are 56" x 46.5" and will be located in the downtown area.
- Sign Type B These signs are larger, 67" x 57.5", and one will be located on "each side" of Havana coming into town on Hwy. 27
- Sign Type C Parking signs, 23"5 x 14



The wording on the signs will be different from those shown above; these were just for estimate purposes. The map below shows the suggested placement of the signs.

Estimates Received

We reached out to multiple companies and received two estimates. One local (Tallahassee) company said they could not handle the work and the others did not respond. Copies of the estimates are attached. Prices may have changed slightly since these estimates. We also may only need four (4) sign A's and we asked for an estimate for five (5).

Estimate 1 – Apogee, Havana, FL - \$17,440 Estimate 2 – Ax Signs, Rancho Santa Fe, CA - \$12,195

We were able to meet with Apogee in person since they are a local company. The signs they proposed appear to be of better quality than Ax Signs. Apogee's estimate includes obtaining any permits needed (we would have to pay for the permit) where as Ax Signs does not include that investigative and potential work. Apogee's estimate includes putting the posts in concrete; Ax Signs specify "anchored into the concrete".

For the reasons above, we plan to meet with Apogee to finalize their estimate and the finite details of the work to be done.

Havana Fire Hydrant Painting Project Update

- Havana Main Street and the Town of Havana announced the contest on May 20th
- Deadline was June 24th with one extension through July 3.
- Every effort was made to reach the entire population of Havana, newspaper, social media including webpage, Facebook, emails, hand delivery of applications and phone calls.
- Of the **200** Fire Hydrants within the Havana town proper, **10** were identified for the **first run** of the project.
- Six Hydrants were selected to concentrate the impact in the downtown area:
 - o The Hazel Baker Community Center
 - Blooming-Deals
 - Coastal Lumber formerly H&H Furniture
 - Subway Subs
 - The Veteran Stage
 - Havana Main Street Offices Poppy's Coffee
- National Fire Hydrant standards were researched and addressed in the rules.
- Eleven Designs were received.
- Judges were selected:
 - Chief of Police Tracey Smith
 - Fire Chief Patrick Coyne
 - City Manager Brad Johnson
- <u>Six Designs</u> were selected by majority rule.
- The remaining designs will be retained for submission into the second round.
- The top six are presented here to the Town Council for approval
- Artists will be notified of their winning design and matched to each Hydrant by the judges
- Water Pressure Identification will be addressed at that time with the artists and any
 necessary design alterations will be made to ensure the hydrants are readily identifiable and
 the safety of the community is ensured.
- The Town of Havana will supply the paint and some brushes for the project, clean and prep the hydrants.
- Winners will receive a certificate and awards as are available.
- Schedules for painting will be arranged between the town and the artists.

The fire hydrants throughout the Town of Havana are due for a fresh coat of paint, and the town is partnering with Havana Main Street, and local Gadsden County artists, to make that happen.

own fire hydrant as part of a Fire Hydrant Painting Event that will bring a fresh coat to the hydrants, as well as an artistic splash of color into the town.

Through June 24, Havana Main Street will be accepting

design proposals from artists in the community.

The goal is to see each hydrant given its own, unique look while allowing the hydrant to still function as an important part of Havana's safety.

Each design proposal should be whimsical, interesting or humorous, as the goal is to catch the eye of visitors and residents to the town. The designs should still be functional and should make sure the

hydrant is clearly visible to firefighters.

No politically-themed or offense designs will be considered.

Any design that pays homage to the hydrant's surroundings or connects the hydrant to an element of the town are preferred.


Every artist who submits a design proposal should be prepared to also paint their proposed plan, should it be selected at the end of the selection and

The design should be appropriate for a public space and should not be political in nature or be offensive in any way. Potential design themes include:

- o Designs with a whimsical or humorous twist that will make viewers smile.
- o Context-sensitive designs that would uniquely connect a particular fire hydrant with its immediate surroundings.
- o Colorful, abstract designs.
- o Selected designs are subject to Town Council approval.
- o Selected designs will be subject to the National Fire Prevention Services (NFPS) color coding, this will be reflected in the colors used on the top and caps.
- o Each Hydrant will be required to have an assigned number clearly marked to be easily recognized from the town of Havana's water system grid.
- The public and private space immediately around the fire hydrant should be kept clean and neat when not directly working on the fire hydrant. <u>Please respect the</u> <u>property.</u>

Registration is open From May 20th. till June 24th. Proposed designs must be submitted during this period, along with a completed application. Winning applicants will be notified by June 30th.

Painting of fire hydrants will begin upon notification of your assigned hydrant from Havana Main Street and approval of the Havana town council and must be completed within 24 hours of the agreed upon start date.

Paint only on the assigned fire hydrant. The caps must be able to open after the paint dries. You must use only the paint provided. Nothing can be attached to the fire hydrant.

If words are included in your design, all words must be approved as a part of the design.

You may use stencils, air brush with masking tape, or freehand your design.

You must apply the design submitted in this application. If you desire to make changes, you must seek approval from Havana Main Street staff prior to changing your design.

If rules are not followed your hydrant will be painted over.

Prizes will be awarded for most whimsical, most patriotic, most creative, and judges' choice.


