Meeting minutes

Call to Order

The meeting was called to order by Mayor Loughmiller at 5:30 pm. Invocation was led by Councilman Reed, followed by the Pledge of Allegiance.

Special Events Permit – Havana Main Street (8/1/2024)

Ms. Wilkerson requested approval for the Special Events Permit submitted by Havana Main Street for the Ribbon Cutting Ceremony at the Slappey Building on 8/1/2024 from 5:30pm – 9:30pm. HMS has requested closure of West 7th Avenue with use of barricades. HMS will provide proof of event insurance prior to event.

Motion made by Councilman Wesolowski to approve the Special Events Permit and the closure of West 7th Avenue. Seconded by Councilwoman Nelson and motion carried.

Grant Award Acceptance – Public Safety Complex \$1,000,000

Ms. Wilkerson presented that the Town received notification on June 28, 2024 from the State Fire Marshal of a grant award for Public Safety Complex in the amount of \$1,000,000. The manager requests the Council to approve the acceptance of the award and to authorize the Town Manager or May to sign all associated documents on behalf of the Town, including the agreement once received.

Councilwoman Nelson inquired if the money awarded will build the new complex. Ms. Wilkerson said they requested \$2,000,000 initially and the last bid they had received was \$1,000,000. The manager stated that prices have decreased and the Town will get it completed. There may be certain items that will need to be provided later such as new desks, etc. If there is a need to go back to State Appropriations later for additional monies, that is an option. The bid process will need to be specific in order for this to be completed.

Councilwoman Nelson made the motion to approve the acceptance of the Award and to authorize the Town Manager or the Mayor to sign all documents on behalf of the Town, including the agreement. Councilman Wesolowski seconded, and motion carried.

Public Hearing for Lot Split – 102 1st Street SE

Mayor Loughmiller requested the clerk to read the Item No by Title. Ms. Alexander, Town Clerk, read Item No. 7, Public Hearing for Lot Split: 102 1st Street SE (Final Hearing). Mayor Loughmiller request Town Manager to explain the procedures for the hearing. Ms. Wilkerson, Town Manager, procedures for the quasi-judicial hearing in accordance to Florida Law.
