

AN ORDINANCE DETERMINING THE AMOUNT AND FIXING THE RATE OF TAXATION AND MAKING THE ANNUAL TAX LEVY FOR THE TOWN OF HAVANA FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 1992 AND ENDING SEPTEMBER 30, 1993; FINDING AND DETERMINING THAT AN AD VALOREM MILLAGE RATE OF 1.102 MILLS, I.E., \$1.102 PER THOUSAND DOLLARS OF ASSESSED PROPERTY VALUE, WILL PROVIDE APPROXIMATELY THE SAME AD VALOREM REVENUE AS WAS LEVIED DURING THE PRIOR YEAR; PROVIDING AND FIXING SUCH MILLAGE RATE AS AND FOR THE RATE OF TAXATION AND OPERATING MILLAGE LEVY FOR THE TOWN OF HAVANA, FLORIDA FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 1992 AND ENDING SEPTEMBER 30, 1993; PROVIDING EFFECTIVE DATE.

WHEREAS, the Town Council of the Town of Havana, Florida has now received from the Property Appraiser of Gadsden County, Florida the certification of taxable values for the year 1992, and it can now be determined what millage rate will provide the same or approximately the same ad valorem tax revenue for the Town of Havana as was levied during the prior year by a calculation of what is known as the "rolled-back rate" pursuant to Section 200.065(1), Florida Statutes.

NOW THEREFORE,

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF HAVANA:

SECTION 1. That it is hereby found and determined that the ad valorem millage rate of 1.102 mills, i.e., \$1.102 per thousand dollars of assessed property value, will provide approximately the same ad valorem tax revenue for the Town of Havana as was levied during the prior year.

SECTION 2. That it is necessary to levy a tax of 1.102 mills, i.e., \$1.102 per thousand dollars of assessed property value, upon all of the taxable property within the corporate limits of the Town of Havana, Florida, excluding exempt property, for the purposes of raising the amount of money necessary to carry on the Government of said Town during the fiscal year beginning October 1st, 1992 and ending September 30th, 1993.

SECTION 3. That for the purpose of raising the amount of money necessary to carry on the Government of the Town of Havana Florida during the fiscal year beginning October 1st, 1992 and ending September 30th, 1993, a direct tax of 1.102 mills on the dollar, i.e., \$1.102 per thousand dollars of assessed property value, is hereby levied upon all of the taxable property within the corporate limits of the Town of Havana, Florida, excluding exempt

property, as listed, described and valued on the assessment roll for the year 1992 by the proper official as provided by law and revised, equalized and corrected as provided by law.

SECTION 4. This ordinance shall take effect immediately upon its passage and approval as provided by law.
