Any questions specific to the RFP itself are answered below. The remaining items will be answered no later than 1/9/2026. An amended RFP has been posted incorporating these clarifications into the body of the RFP. Any material changes are marked with strikethrough or highlight.

Q: P. 18 states submit five(8) copies no later than November ______ 2025 by 2:00 p.m. local time. How many copies are needed and what is the submittal due date?

R: 8 Copies; January 28, 2026 10:00 a.m. local time: amended RFP is posted at www.townofhavana.com correcting this item.

Q: How many copies of the Price Proposal is the proposer to submit?

R: 8 Copies

Q: On page 27, it references contract start date of January 1, 2026, however proposals are not due until Jan. 7. Please advise.

R: Contract start date will be no earlier than March 1, 2026. Proposal due date has been extended to 1/28/26 at 10:00 am local time.

Q: The pricing form on Attachment A appears to be a draft that is not applicable to this scope of work. Does the City have a final form or would it be acceptable to create our own annual cost table.

R: Proposers may use the provided table OR submit their own, as long as all expenses are clearly delineated so that a true comparison may be easily made.

Q: On p.18 #5, would you like 8 or 5 copies of proposal?

R: 8 copies; amended RFP is posted at www.townofhavana.com correcting this item.

Q: Also is states due November _____ 2025 - assume that is a typo?

R: RFP is due January 28, 2026 by 10:00 am local time; amended RFP is posted at www.townofhavana.com correcting this item.

Q: On page 13 – we'd appreciate clarification on the biosolids section. Do we need to include costs for transporting biosolids to your current location?

R: You can include costs of biosolids disposal or not. Please list this item as a separate line item in your cost proposal if biosolids disposal is included.
